- * Remuneration: An annual registration reward of 10,000 yen will be paid in the month following the completion of your registration as an OIS interpreter.

Gratuity is paid per case. Basic per-case gratuity is 3,000 yen for the provision of information, consultation, interpretation, etc. A premium fee is paid for nighttime or Sunday services, making it to 3,750 yen and 4,050 yen respectively.
